Safety and Quality in the Medication Use System (728-608): Required 3 credit course in the professional (Pharm.D.) curriculum which enrolls 130-140 pharmacy and engineering students in Spring semester. This course provides students with the fundamentals of safe medication management regardless of their practice environment and professional discipline. The content addresses the problems of medication errors and quality in health care, problem resolution, methods/techniques of assessment, and quality management. This course is cross-listed in the Department of Industrial and System Engineering and is a required course in the Patient Safety Certificate Program. I coordinate and provide the majority of lectures in this course.

Professional Decision-Making in Pharmacy Practice (732-618): Required 2 credit course in the professional (Pharm.D.) curriculum. The goals of this course are to expose students to the knowledge and sensitivity needed to communicate and intervene effectively in a variety of psychosocial situations with different patient populations. I coordinate and provide content expertise in this course.

2010-2012

Pharmacists and the Health Care System (732-414): Required 3 credit course in 2017 the professional (Pharm.D.) curriculum. The goals of this course are to introduce concepts and principles related to managing pharmacy environments for patient care, operational economics in pharmacies, pharmacoeconomics and outcomes, and aspects of marketing in pharmacy and patient care. I provide 6-8 lectures in this course.

B. Graduate Teaching - Courses

Principles of outcomes assessment and health economics will be covered, including applied pharmacoeconomics, health-related quality of life, decision analytic models, and formulary management.

Personal Finance for the Healthcare Professional (PPRA 648): Elective 1.5 credit course offered in the professional (Pharm.D.) curriculum. This course is designed to provide students with the tools needed to financially succeed after graduation. investing, loans and credit, debt consolidation, home purchasing, and basic money management.
